

RULES AND REGULATIONS FOR THE WIZZ AMBASSADORS PUBLIC VOTING 2017

1. Organiser, The Voting, Definitions

1.1. Wizz Air Hungary Ltd. (Wizz Air), with registered offices in Budapest Kőér street 2/A, Hungary (**Organiser**), is organising a free public voting with no purchase required titled "WIZZ Ambassador Public Voting 2017" (**Voting**), which is to run on the Facebook web site at <http://www.facebook.com/wizzaircom> (Wizz Air Facebook Page) in the WIZZ Ambassador Facebook Application from 26nd of May 2017 12:00 (GMT +1) to June 9, 2017 16:00 (GMT+1).

1.2. The Voting will be announced on the Wizz Air Facebook page.

1.3. The aim of the voting is to select the 31 out of 84 candidates in 14 countries who have the highest number of Votes on Wizz Air Facebook page in the Application during the term of the competition as further specified in clause 4. below.

1.4. Definitions

Entrant: any person submitting a Vote according to the present terms and conditions

Vote: Any vote submitted via the Application by and Entrant as further described in clause 3.

Application: The WIZZ Ambassador Facebook Application where the candidates are listed and introduced with a profile page and where the voting takes place as described in clause 3.

2. Entrants

2.1. Participation in the Voting is open to any person with Internet access and having a Facebook profile.

3. Voting

3.1. Voting period: from 26 May 2017 12:00 (GMT +1) to 9 June, 2017 16:00 (GMT+1).

3.2. In order to vote for a candidate Entrant has to enter the Application within the Wizz Air Facebook Page.

3.3 Voting rules: Each Entrant can submit only one vote per day for the same candidate. Each Entrant can vote for two or three different candidates from each country every day (depending on the number of winners in the given country as further specified in 4.1). One Entrant can submit maximum 31 Votes per day. Voting restarts ever day at 00:00 (GMT+1) within the voting period.

3.4. Voting method: Votes will be accepted only via the Internet. Place of voting: Application on the Wizz Air Facebook Page. Voting happens in two steps:

First step: Entrant has to visit the Wizz Air Facebook page and there in the Application they should tap or click on the heart shape of the preferred candidate. A heart shape icon is placed on every candidate's photo or in the candidate's profile page.

Second step: Entrant has to tap or click on the 'Submit votes' button.

All submitted Votes are final, there is no possibility to revoke submitted Votes.

3.5. All Votes shall be submitted directly by the person having the specific Facebook account.

3.6. Votes made online using methods generated by a script, macro or the use of automated devices will not be counted.

4. Voting's results

4.1 The thirty-one (31) candidates reaching the highest number of votes will win, in accordance with the following further conditions:

- a) for Bosnia & Herzegovina, Bulgaria, Czech Republic, Georgia, Latvia, Lithuania, Macedonia, Moldova, Serbia, Slovakia and Ukraine:
the first 2-2 candidates from each of the above listed countries reaching the highest number of votes in amongst the candidates from the given country;

- b) For Poland, Romania and Hungary
the first 3 - 3 candidates from each of the above listed three countries reaching the highest number of votes amongst the candidates from the given country (respectively), with the condition that two of the candidates per each country must be from the country's capital, respectively from Warsaw, Bucharest, and Budapest.

The Voting's results are final.

5. Announcing the Voting's results

Wizz Air will announce the Voting's results, i.e. the 31 new WIZZ Ambassadors, on the Wizz Air Facebook page within 5 days after closing the Voting.

6. Limitation of Liability

6.1. By submitting a Vote, all Entrants agree to release, discharge, and hold harmless the Organiser and its partners, affiliates, parents, subsidiaries, agents and all of their employees, officers, directors, agents and representatives from any and all claims, losses, and damages arising out of their participation in this Voting.

6.2. The Organiser assumes no responsibility for any error, omission, interruption, deletion, defect, or delay in operation or transmission; communications line failure, for votes lost, delayed or corrupted, or due to computer error in transit.

The Organiser is not responsible for any problems with or technical malfunction of any telephone network or lines, computer online systems, servers or providers (including the availability of Facebook), computer equipment, software, failure of any email entry to be received on account of technical problems or traffic congestion on the internet or at any website, human errors of any kind, or any combination thereof, including any injury or damage to entrants' or any other persons' computers related to or resulting from entering into Voting. Attention is expressly drawn to the fact that the Internet is not a secure network. Therefore, the Organizer may not be held liable for contamination by any virus or third-party intrusion into the computer system of Voting's Entrants and refuses all liability with regard to the Entrant's use of Wizz Air Facebook Page or the Application. More specifically, the Organiser cannot be held liable for any damage caused to Entrants, their IT equipment or data stored therein, or for any consequences that might arise therefrom with regard to their personal or professional life.

6.3. Any Vote may be disqualified in case the Vote is against the present terms and conditions or any way against the law in any parts.

6.4. Should the Vote be unavailable during the Voting or if the information supplied by the Entrants in Voting be destroyed for any reason not attributable to it, Organiser hereby refuses all liability.

7. Disputes

Entrants agree that this Voting shall be subject to and governed by the laws of Hungary, and the forum for any dispute shall be the competent Hungarian court. To the extent permitted by law, the right to litigate, to seek injunctive relief or to make any other recourse to judicial or any other procedure in case of disputes or claims resulting from or on connection with this Voting are hereby excluded and any Entrant expressly waives any and all such rights.

8. Final provisions

8.1 By entering this Voting the Entrant participating in the Voting declare the full, unrestricted and unreserved acceptance of these Terms and Conditions to be found in the Application footer.

8.2 The Organiser does not reimburse the Entrants for any costs related to their participation in the Entrant.

8.3 Entering in the Voting shall not entitle the participant in the Voting for any prize or award.

8.4 Wizz Air does not process any personal data in relation to this Voting. The privacy policy of Facebook Inc. applies to any data processing in relation to the Voting.

8.5 These terms and conditions constitute the sole document that sets forth the terms and conditions of the Voting.

8.6 In the case of any doubts concerning the application of these terms and conditions, the Organizer has the right to issue a binding interpretation of its provisions.

8.7 Promotional and advertising material on the Voting is for information purposes only. Only the provisions of these terms and conditions are legally binding.

8.8 Wizz Air reserves the right to amend or alter the terms and conditions of Voting or withdraw the Voting at any time and reject Votes from Entrants not entering into the spirit of the Voting.

8.9 This Voting is not sponsored, administered or organized by Facebook, Inc. Facebook, Inc. shall not be responsible for any of the provisions above.
